In continuation to the Provisional Selection notifications of Group - IV Services Dt: 14/11/2024, 30/11/2024, 12/02/2025, 10/04/2025, 13/10/2025 and 07/02/2026 for Notification No. 19/2022 Dt.01/12/2022, it is hereby informed that, the provisional selection list of 08 candidates is now being released in place of withheld candidates.

In the earlier selection dated 14/11/2024 the candidates who kept withheld as they obtained their degrees other than the territorial jurisdiction is not a valid qualification as per the Hon'ble Court orders in W.P. Nos. 9262 of 2026, 31390 and 35447 of 2024, 1217, 1543, 6112 and 31826 of 2025 Dt. 29/04/2026 and W.A No. 176 of 2026 Dt. 02/04/2026 as and the selection of next meritorious candidates is being released subject to following conditions.

1. That success in the examination confers no right to appointment unless the appointing authority is satisfied after such enquiry as the case may be as considered necessary, that the candidate having regard to his/her character and antecedents is suitable in all respects for appointment to the service.
2. That the candidate is found physically fit for the post.
3. That the candidate should produce such original certificates as required in accordance with the rules/notification.
4. The concerned Unit Officers issue appointment orders with a condition subject to the outcome of SLP (C). No. 14971/2026 pending before the Hon'ble Supreme Court.
