**PROVISIONAL SELECTION NOTIFICATION**

It is hereby informed that the Provisional Selection Notification after Relinquishments for the posts of Physical Education Teachers in various Residential Educational Institutions Societies vide Notification No.16/2017, dated:14/04/2017 has been published on 17/09/2024, in which 02 vacancies were kept withheld, as the Selection for these vacancies was dependent on the clarification on the claim of ST Agency area certificate.

Since, the ST Agency Area GENUINE report of the relevant candidates have been received from the concerned Departments, in continuation of the Provisional Selection Result Notification dt: 17/09/2024 & 20/01/2025 after Relinquishments for the posts of Physical Education Teachers in various Residential Educational Institutions Societies vide Notification No.16/2017, dated:14/04/2017, the Result of 02 vacancies kept withheld earlier is being released now with the following conditions.

1. That success in the examination confers no right to appointment unless the appointing authority is satisfied after such enquiry as the case may be as considered necessary, that the candidate having regard to his/ her character and antecedents is suitable in all respects for appointment to the service.
2. That the candidate is found physically fit for the post.
3. That the candidate should produce such original certificates as required in accordance with the rules/notification.
